\*For the purpose of revision courses, someone is defined as LCA student if he/she is actually following the normal course at LCA. That student will be eligible to pay the price of Rs 1,500/- (Rs 2,500 for SBL) ONLY for the paper taken as part of normal courses. All other papers taken for revision purposes ONLY will be charged at the rate of Rs 2,000/- (Rs 3,000 for SBL) per paper irrespective of whether the student is already enrolled on normal courses for other papers.

Summary of terms and conditions of enrolment at LCA

1. Students are advised to consult the Student Handbook on LCA's website before enrolment

2. A full payment per paper for each course is required at the time of enrolment.

3. All payments are non-refundable, and can be transferred to later start dates, to other students or to other ACCA courses. Transfers will be accepted

within a period of 30 days from the date payment was effected or 2 weeks after the ACCA results are made official, whichever is later. After that period,

any transfer /refund may be subject to deductions from the initial payment on a proportional basis (with a minimum retention fee of Rs 500/- per paper).

In case LCA does not hold a course, the full payment will be refunded to the applicants.

4. A minimum fee of Rs500 will be charged to students for all dishonored payments. The College reserves the right to report offenders to ACCA.

5. The course fees include the provision of textbooks and revision kits as determined by LCA.
